Input of RWE Supply & Trading GmbH to the binding alternative allocation procedure for the HU-SK-AT route

Dear Sirs,


RWE Supply & Trading GmbH (RWEST) very much welcomes the initiation of the 'binding alternative allocation procedure for the HU-SK-AT route' as well as the invitation to the 'HU-SK-AT Shipper information day' on 5 June 2018.

As already highlighted by RWEST as well as other shippers at the 'HU-SK-AT Shipper information day' on 5 June 2018, the latest execution date of the step back right from contracts is of high relevance for a participation in the HU-SK-AT Open Season procedure. We request that the proposed 'Bidders latest execution date of step back right from contracts concluded upon positive Economic Test I or II' (which is currently proposed for the 28 December 2018) should be moved by one quarter to the 31 March 2019. The date shall not be set before the 26 March 2019, which is the last date to have the transport contracts allocated under the Open Season procedure at the Romanian-Hungarian interconnector (RoHu). Reason is that only by this date, bidders and participants under the RoHu procedure will have final and legal clarity on their allocated transport capacities. Most importantly, the RoHu re-bidding process starts only by the 4 February 2019 and continues until the end of March 2019.

Many thanks again for the constructive discussions on the shippers information day.
